Re: Third Judicial District New Magistrate Judge Nominations

Dear Justice Stegall and Members of the Third Judicial District Nominating Commission:

On behalf of the Kansas Women Attorneys Association (KWAA) and in my capacity as president of this organization, I want to thank you for serving on the Third Judicial District Nominating Commission. Your dedication to our judicial system and the selection of fair and impartial judges is valuable and appreciated.

As you work to fill this current vacancy, KWAA reminds you that an important consideration for your impending deliberations is the demographic representation of the Third District's bench. We direct your attention to *The Gavel Gap: Who Sits in Judgment on State Courts*, a report issued by the American Constitution Society for Law and Policy, which shows that state courts do not adequately reflect the diversity of our citizens.¹ As you can see from this study, Kansas' judiciary received an "F" on its report card, based on its assigned gavel gap score of -57.²

Half of the population is female and a quarter of Kansas residents are racial and ethnic minorities³; but, as you can see, these groups are underrepresented on our state court benches. KWAA reminds you that the benefits of a diverse bench are largely undisputed. Research has consistently shown that when courts reflect the populations they serve, judges bring a broader range of experiences to the judicial decision-making process, which, in turn, results in increased confidence in the fairness and impartiality of our justice system.⁴

KWAA understands your mission is to select the most qualified candidates, regardless of race, ethnicity, or gender, and we are confident that no member of the Nominating Commission enters the process with explicit biases. But, as reflected by research documented by the American Bar Association,⁵ many decisions are unknowingly impacted by implicit bias. KWAA asks that you remain mindful of the impact of implicit bias on your deliberations and encourages you to recommend diverse candidates, including women and persons of color, when selecting candidates to fill these newly-created judicial positions.

Thank you for the important role you play in addressing the lack of diversity among judges in our state courts. We strongly urge you to consider these points when implementing this historic collaboration between all three branches of state government that created 14 new district judge divisions and nine new district magistrate judge positions. Your work will not only ensure that the Judicial Branch can better meet the case processing needs of Kansas communities, but will be instrumental in ensuring that Kansans can access a court system that is representative of the people it serves.
